Parents having trouble to integrate and professional and social problems

After one day and a half of work, the participants of « parents workshop » have observed the followings :

THE PROBLEMS THAT ARE OBSERVED :

- 1- The immigration (in Turkey the set of issues is the rural exodus), the problems of single-parent families, and the consequences on the children's behavior (psychological instability, disruptions, absence of landmarks and links with the society, loss of personality and identity) and the academic failure to which they are faced
- 2- The violence sustained by women generally in a Mediterranean society dominated by the patriarchal thought, (it's the case in Turkey, Greece and in the south of Italy). In front of this situation all the participants agree to note the absence of efficiency laws protecting the victims.
- 3- The malnutrition and the dangerous consequences on the public health. (the proliferation of Fast-food, canned food and frozen products). Although that is not a part of initial eating habits of populations in question, these populations have adopted in their everyday life these new eating behavior.
- 4- The illiteracy of women and the ignorance of the world that surrounds them make very difficult the efficiency of interventions of family-planning programs (to resort to method of contraception, the abortion, the fight against sexually transmitted diseases, the education of children, hygiene, health, vaccinations...)
- 5- The suicide is a recurrent information now ; prevention actions are devoted to it : to do all in one's power to prevent the suicide by fighting against the reasons that drive them to this final solution.
- 6- The economic and monetary crisis make more difficult the conditions of integration of job seeker and require more actions of support to families confronted with serious economic, psychological, educational difficulties.



- 7- The welcome of foreign populations and the preoccupation of their integration call the organizations to develop more and more heavy programs : professional integration, language learning, administrative and juridical aid, housing, educational support to children

FOR A MORE SUCCESS OF ACTIONS, NECESSITY OF

- 1- Placing the actions in the continuity of work and following individual files until its end.
- 2- Using the networks and mutualizing the means that are at disposal (juridical, administrative educational, preventive,...)
- 3- A collaboration between organizations, and the authorities (including the judicial system – justice/police) in order to set a common action plan in front of the problems of the society.
- 4- Making the beneficiaries of support programs participants in the work of organizations. (the person comes to the organization to ask help, he ends in participating and helping the others his turn)

CHILDHOOD AND EDUCATION : A PRIORITY GOAL

- 1- Learning from early ages the respect of the other and the good leaving together in harmony and solidarity between the constituents of the society.
- 2- Preparing a better future for the future generations throughout the education, the prevention

PROBLEMS THAT STILL NEED TO BE RESOLVED :

The lack of means allocated to organizations presents in the field despite the big task they are in charge of.

All European countries, all States and for many years, have charged the organizations of resolving the problems of the society but without giving them the necessary means. The monetary crisis in Europe and in the world have aggravated the situation (Italy, Spain, Greece)

To sum up, what is missing nowadays is not the will of each other but juridical, financial means for organizations led to answer social difficulties more and more tough, complicated, and in raising.
